Who Should Attend & Entry Requirements

- The Global Directorship Programme caters to individuals at the board level, including directors, entrepreneurs, intrapreneurs, change-makers, corporate professionals, policy makers, department heads in corporates, government departments, public sector and non-profit organisations, and professional firms.
- Applicants should have more than 15 years of work experience and hold a position of significant influence within their organisation, enabling them to impact strategy and strategic decisions.
- To be eligible for Intake A & B, applicants must demonstrate a strong commitment to sustainability and a desire to drive their organisation beyond conventional business practices. Selection process applies, applications are subject to CISL selection panel's final approval.
- There are very limited seats available for each intake, and they will be allocated on a first-come-first-served basis.
